Lease.

THIS LEASE made and entered into this 22nd day of September, 1910, by and between Clarissa Bell and Jack Bell her husband, parties of the first part, and John N. Hodges, party of the second part, WITNESSETH:

That said first parties in consideration of the sum of Ten Dollars (\$10.00) cash in hand paid, the receipt of which is hereby acknowledged, and the other covenants and agreements hereinafter set forth, do by these presents demise, lease and let unto the second party the following described property, situate in Tulsa County, State of Oklahoma, and thus more particularly described as follows:

Beginning at the northwest corner of the Northwest Quarter of the Northwest quarter of Section Seven (7) Township Nineteen (19) North, range Twelve (12) East, running thence East one hundred and fifty (150) feet to a stake, thence South at right angles One hundred and sixty (160) feet to a stake, thence West One hundred and fifty (150) feet to a stake, thence North One Hundred and Sixty (160) feet to the place of beginning, and all the appurtenances thereunto belonging, the same being commonly known as the "Bell Grocery".

To have and to hold the said above described premises unto the said second party from the 22nd day of September, 1910, to the 22nd day of March 1911, and said second party in consideration of the premises herein set forth agrees to pay to the first parties as the rental for the above described premises the sum of Sixty (\$60) Dollars, payable monthly in installments of Ten Dollars (\$10) each. The Ten dollars cash consideration paid and above referred to is in full satisfaction of the first month's rent.

The covenants and agreements of this lease shall extend to and be binding upon the heirs, executors, or assigns of the parties hereto.
