Mohrman, his heirs, executors, administrators, or assigns, all of the wood and timber now growing and upon the following described real estate to-wit:

Northeast Quarter of the Southeast Quarter East Half of the South west Quarter of the Southeast Quarter; the Southeast quarter of the north east Quarter, Lot One and the Southeast Quarter of the Southeast quarter of Section One (1) Township Nineteen (19) North, Range Eleven (11) East.

Hereby granting unto the said S.S. Mohrman his heirs, executors, administrators or assigns the exclusive right to go upon the said land and cut and remove any and all timber now growing or lying upon said land Said timber to be removed within five years from the date hereof.
