TRUSTEES DEED.

WHEREAS, on the 7th day of October, 1908, J. Fred Dee and Nellie E. WITNESSETH, That for and in consideration of the sum of Fourteen Hundred Eighty five pollars (\$1485.00) the receipt whereof is hereby acknowledged, the party of the first part, as such Trustee, has granted, bargained, sold and conveyed, and by these presents does grant, bargain, sell and convey unto the party, of the second parties heirs and assigns, the following described real property, lying and situate in the Buena Vista Park Addition to the City of Tulsa, Tulsa County, Oklahoma, to-wit:

Lot 14 in Block 5, Lots, 5, 7, 8, 15, 16, 17, 19, 20, 21 in Block Seven (7) Lots 43, 23, 24, 25, 26 & the South half of lots 27 in Block Six (6) Lots 6 & 7 Block Three (3) Lot 9 Block 2, Lot 3 Block 4 together with the tenements hereditaments and appurtenances thereunto belonging or in any wise appertaining.

To have and to hold the same unto the said parties of the second part . their heirs and assigns forever.

The party of the first part covenants and agrees with the party of the second part that the covenants of warranty and all covenants and agreements by the said parties grantor in said truct deed of date October 7th, . 1908, shall run to the party of the second part herein, and that the party of the first part will, as such tru stee, forever warrant and defend the title to the said real property, in and to the party of the second parties heirs and assigns, against all claims or acts of the first party and tose of all persons claiming, by, through or under it and no other.
