

X Tract No. four.

A tract of land situate in the South half of the Southeast Quarter of the Northwest Quarter of Section Thirty-four, in Township Twenty north, Range Thirteen East, Tulsa County, Oklahoma, and more particularly described as follows:-

Beginning at the center of said Section Thirty-four; thence running North along the north and South Center line of said section Thirty four, a distance of Six Hundred Sixty (660) feet, more or less, to the North line of ~~said~~ ^{the} South Half of the southeast Quarter of the Northwest Quarter of said section Thirty four; thence west along said North line, a distance of ten (10) feet to a point twelve and five tenths (12.5) feet perpendicularly ~~the railroad track of said railroad company, thence southerly parallel to and twelve and five tenths (12.5) feet perpendicularly distant from the center line of said track,~~ a distance of Six Hundred Sixty two and two tenths (662.2) feet to the south line of the Northwest Quarter of said section Thirty four thence East a distance of Sixty one and Sixtenths (61.6) feet to the place of beginning, containing Fifty-four Hundredths (.54) of an acre more or less.

The appropriation and condemnation of said tracts of land hereinbefore described under the headings of Tract No. one, Tract No. Two, Tract No. Three, Tract No. Four, respectively, are, for the purposes of the St. Louis and San Francisco Railroad Company, for right of way, side track, turn outs and other railroad purposes, for use in the construction, maintenance, renewal and operation of the line of railroad and appurtenances of the St. Louis and San Francisco Railroad Company.

And the court adjudge, decrees and orders that there be and hereby is allowed and awarded compensations and damages on account of the appropriation and condemnation of each of said respective tracts of land hereinbefore described, to the persons hereinafter named as follows, to-wit:

Tract No. One to Greenville Pace Hefflefinger, \$315.00

Tract No. Two, to Pace Geral Hefflefinger \$65.00

Tract No. Three to - - - - -
and Tract No. Four to Herbert L. Lynch, \$366.00

Upon the payment by the said St. Louis and San Francisco Railroad Company of said compensation and damages by deposit of the same with the Clerk of this Court, and upon the payment of those costs in this case taxed against the said Railroad Company, the said St. Louis and San Francisco Railroad Company shall have the right, for the purposes aforesaid, to hold, possess, use and enjoy the said tracts of land hereinbefore described with all the privileges and title which pertains to such right, for all of the purposes aforesaid.

It is ordered and decreed that the costs in this case shall be taxed as follows:
