And whereas, Walter D. Wright, leased to G.N. Wright, Jr. for oil and gas purposes, by said ~~lease~~.

All of the Northwest quarter ($\frac{1}{4}$) of the Northwest quarter ($\frac{1}{4}$) of Section eleven (11) in Township Nineteen (19) North, of range Fourteen (14) East, of the Indian Meridian, in Tulsa County, Oklahoma, subject to the conditions in said oil and gas lease contained, and which said oil and gas lease was mutually executed by the said Walter D.
