STIPULATION INCREASING OIL ROYALTY EXTENDING TERM OF LEASE AND
CANCELLING REGULATIONS OF OCTOBER 14, 1907.

(To be executed in quadruplicate)

Whereas the Secretary of the Interior has heretofore approved an oil and gas mining lease dated Oct , 16 1907 entered into by and between Squirrel Sequíchie Braggs, Okla. lessor and Percy D. McConnell, Bartlesville, Okla. lessee and wherein the oil royalty is stipulated to be ten per cent of the gross proceeds, and

Whereas, the undersigned the present owner of said lease is willing to increase the royalty on oil in said lease to twelve and one half per cent of the gross proceeds on condition that the term of said lease shall be extended to as long as oil or gas is found in paying quantities, and that said lease when extended shall have all the rights privileges, conditions, and terms of the lease form approved and issued April 20, 1908, by the Secretary of the Interior, and that the stipulations subjecting said lease to the regulations of June 11, 1907, as amended October 14, 1907, be revoked and cancelled;
