RENTAL CONTRACT

Made and entered into on this the 29th day of September, 1910, by and between James Helterbrand, of Proctor, Oklahoma, the legal guardian of John W. Helterbrand, a minor, party of the first part, hereinafter called the lessor, and Isaac A. Wilson, of Dawson, Oklahoma, party of the second part, called the lesse.

In consideration of the sum of Forty Dollars per annum, payable on the first day of January, of each and every year during the life of this control, the first payment to be made by lesses to lessor on the first day of January, 1911, the lessor rents to sald lessee, his heirs and assigns, the following described tract of land, located in Tulsa County, State of Oklahoma towit:
