

And having examined said leases and heard evidence upon the same and it appearing that said lease is for the best interest of said minors estate, and is in proper form, and covers only the period of said wards minority, and is in conformity to the order of the court heretofore made in the premises, and that the bonus of Eighty Dollars paid for said lease is a sufficient and reasonable bonus, and being well and sufficiently advised in the premises;

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED by the Court that said lease be and the same is hereby ratified, approved and confirmed and that a certified copy of this order be attached to each of the three parts of the lease here and now presented for approval and that one part thereof with such certified copy attached be delivered to the lessee and the third part to remain on file with the papers in the case.

#### CHATTEL MORTGAGE

THIS MORTGAGE, made this 5th day of October, in the year 1910, by J.P. Proctor and J.T. Proctor, of Turley, Tulsa Co., Oklahoma, by occupation farmers, mortgagor, R. E. Thompson, Adair, Okla. by occupation a banker, mortgagee.

WITNESSETH, That the mortgagor mortgages to the mortgagee the following described property, to-wit: One Black mare, 4 yrs. old, about 16 hands high, no brands, has scar on left hind leg called "Bess"; has bay mare colt, by side, value of mare and colt \$275.00; One black horse, 8 yrs. old, about 15 1/2 hands, no brands or marks, has white spot in left flank, called "Charlie", value \$150; one bay horse, 6 yrs. old, about 16 hands, no brands or marks, has white in forehead, called "Mike", value \$100; one gray mare mule, 6 yrs. old, about 15 hands, no brands or marks, called "Kit", value \$165; one sorrel mare mule, 5 yrs. old, about 15 hands, no brands or marks has white in forehead, called "Red", value \$165; one bay mare mule, 2 yrs. old, about 15 hands, no brands or marks called "Nell", \$150; one bay horse mule, 2 yrs. old, about 15 hands, no brands or marks called "Bugs", value \$150. Located two miles S.E. of Turley, Okla. on farm of J.M. Riley located in Tulsa County, Oklahoma, as security for the payment to them of Eight Hundred and no/100 dollars (\$800.00) due and payable according to the terms of a promissory note, of which the following is a synopsis, namely:
