the tracts leased, should the Secretary of the Interior determine that the interests of the lessor demand such action.

The party of the second part further agrees to carry on operatins in a workmanlike manner to the fullest possibe extent, unavoidable casualties excepted; to commit no waste on the said land, and to suffer no waste to be committed upon the portion in his occupancy or use, to take good care of the same, and to promptly surrender Kand return the premises upon the termination of this lease to the party of the first part or to whomsoever shall be lawfully entitled thereto, and not to remove therefrom any buildings or permanent improvements erectedthereon during the said term by the said party of the second part, but said buildings and improvements shall remain a part said land and become the property of the owner of the land as a part of the consideration for this lese, in addition to the other consideration herein specified, excepting the tools, boilers, boiler houses, pipe lines, pumpting and drilling outfits, tanks, engines, and macinery, and thecasing of all dry or exhausted wells, shall remain the property of the said party of the second part and may be removed at any time before the expiration of sixty days from the termination of the lease, that he will notpermit any nuisance to be maintained on the premises under his control, nor allow any intoxicating liquors to be sold or given away for any purposes on such premises; that he will not use such premises for any pther purposes than tose authorized in this lease, and that before abandoning any well he will securely plug the same so as to effectually shut off all water above the oil bearing horizon.

And the said part -- of the second part further covenants and agrees that he will keep an accurate account of all oil mining operations, shwing the sales, prices, dates, purchasers, and the whole amount of oil mined or removed, and all sums due as royalty shall be a lien on all implements, tools, movable machinery, and all other personal chattels used in said prospecting and mining operations, and upon all of the unsold oil obtained from the land herein leased, as security for the payment of said royalty.

And it is mutually understood and agreed that this indenture of lesse shall in all respects be subject to the rules and regulations heretofore on + that may hereafter be lawfully prescribed by the Secretary of the Interior relative to oil and gas leases in the Cherokee Nation, and that this lease, or any interest therein, shall not, by working or drilling contract, or otherwise, or the use thereof, directly or indirectly, be sublet, assigned, or transferred, without the consent of the Secretary of the Interior first obtained, and that should he or his sublessees, heirs, executors, administrators, successors, or assigns violate any of the covenants, stipulations, or provisions of this lease, or any of the regulations, or fail for the period of sixty days to pay the stipulated royal ties provided for herein, then the Secretary of the Interior after ten days from notice to the parties hereto, shall have the right to avoid this indentue of lease, and cancel the same, when all the rights, franchises, and privileges of the lessee, his sublessees, heirs, executors, administrators, successors or assigns hereunder shall cease and end without resorting to the courts and without further proceedings and the lessor shall beentitled to immediate possession of the leased land and the permanent
