OIL AND GAS MINING LEASE upon Land Selected for allotment, Creek Nation Indian Territory

(Section 17 Act of June 30, 1902 32 Stat 500)

THIS INDENTURE OF LEASE Made and entered into, in quadruplicate on this 23rd day of Octber, A.D. 1905, by and between Sarta Cowe and Chowey Kinney, both of Wetumpka, Indian Territory, sole heirs at law of Wicey a citizen of the Creek Nation, deceased of Wetumpka, Indian Territory, parties of the first part and L.S. Skeltenof Okmulgee, Indian Territory, party of the second part, under and in pursuance of the provisions of Section 17 of the act of Congress approved June 30, 1902, and the regulations prescribed by the Secretary of the Interior thereunder.

WITNESSETH: That the parties of the first part, for and in consideration of the royalties, covenants, stipulations, and coditions hereinafter contained, and hereny agreed to be paid, observed, and performed by the party of the second part, his heirs, executors, administrators, and assigns, do hereby demise, grant, and let unto the party of the second part, his heirs, executors administrators and assigns for the term of fifteen (15) years from the date hereof all of the oil deposits and natural gas in or under the following described tract of land lying and being within the Creek Nation and within the Indian Territory to-wit: The South East Quarter of the South East Quarter (Homestead deed) and the West Half of the South Bast Quarter and the North East Quarter of the South East Quarter of Section Thirty six (36) township, Nineteen (19) North, range Eleven (11) East, of the Indian Meridian, and containing One Hundred and Sixty (160) acres, more or less, with the right to prospect for, extract, pipe store, refine and remove such oil and natural gas, and to occupy and use so much only of the surface of said land as may be reasonably necessary to carry on the work of prospecting for, extracting, piping, storing, refining, and removing such oil and natural gas, including also the right to obtain from wells or other sources on said land by means of pipe lines or otherwise a sufficient supply of water to carry on said operations, and including still further the right to use such oil and natural gas as fuel so far as it is necessary to the pro-
