Said pipe line shall be laid and maintained by the said The Prairie Oil & Gas Company at its own cost and expense in such manner as not to interfere with the use, by the city of Tulsa, for any purposes, of the premises where laid; and shall be by the said The Prairie Oil & Gas Company altered, moved or removed at any time, at the expense of said Company, should the needs of the said City require, and the City shall be the final judge of such necessity.
