THIS INDENTURE, Made on this 4th day of October, 1910, by and between G.W. Hutchins, as the duly appointed, qualified and acting guardian of the estate of Fred Gaskine, a minor, of Tulsa, Oklahoma, party of the first part and C.C.C. White, of Tulsa, Oklahoma, Party of the second part,
