DEED OF CONVEYANCE

This deed of Conveyance Made and entered into by and between C.P. Chenault, party of the first part, and Hettie Armstrong, party of the second part, both parties of Tulsa County, Oklahoma, is to witness:

That for and in consideration of \$1.00 receipt of which is hereby-acknowledged, and for other valuable considerations not necessary to mention, party of the first part hereby transfers, sells, assigns sets over and conveys to Hettie Armstrong, party of the second part, her heirs and assigns forever, to be held by her as her separate and sole estate, all his right, title and interest in and to that certain described tract or parcel of land in Tulsa County Oklahoma, described as follows, to-wit: Lot Four (4) of Block Fourteen (14) in the Cherokee Heights Addition of the City of Tulsa, Oklahoma, together with all the improvements and appurtenances thereunto belonging.

To have and to hold the said described property unto said Hettie Armstrong, her heirs, and assigns forever.

It is agreed between the parties hereto that there is the sum of One Hundred Fifty Dollars (\$150) to be paid to C.P. Chenault on or before the 20th day of October, 1910; and in order to secure said payment, said Chenault hereby retains a lien upon the said described lot of land and agrees to release said lien of record when said \$150.00 is paid.
