Gibson, by The Gulf Pipe Line Company of Oklahoma, the receipt whereof is hereby acknowledged I do hereby grant and convey unto said Gulf pipe Line Company of Oklahoma, its successors and assigns, the right to locate, maintain and operate a pipe line for the purpose of conveyance of oil over, through and upon that certain tract of land situated in Tulsa County Okla and thus described: SE of SE of NE Sec. 23, \$ 22 N.R. 12 E. 40 rods.

Also there is hereby granted a right to erect and maintain a telegraph and telephone line.
