RIGHT OF WAY AGREEMENT.

For and in consideration of the sum of One (\$1.00) pollars to him in hand paid by Galbreath Gas Company the receipt of which is hereby acknowledged, Newman Litka by Richard Litka, Gdn. do hereby grant to the said Galbreath Gas Company, a corporation, its successors or assigns, the right of way to lay, maintain, operate, relay and remove a pipe line for the transportation of oil or gas and erect, maintain, operate and remove telegraph and telephone lines with right of ingress and egress to and from the same, said right of way being more fully described by plat of definite lacation, approved by the Secretary of the Interior, on ---- on, over and through certain lands allotted to Newman Lit ka, a citizen of the Creek Nation, Roll No. --- situate in the County of Tulsa, and State of Oklahoma, and described as follows:

N/2 of SE/4 and SW/4 of SE/4 Section 25, Township 19 N. Range 11 E, The said grantors, their heirs, or assigns are to fully use and enjoy the said premises except the easement for the purposes hereinbefore granted to the said Galbreath Gas Company, its successors and assigns

The said Galbreath Gas Company for itself and its successors or assigns hereby covenants to bury its lines of pipe so that the same will not inter fere with the cultivation of said premises.

In consideration of the sum of one dollar in hand paid, it is hereby fu rther agreed that the Galbreath Gas Company, its successors, or assigns, may at any time lay additional lines of pipe alongide of the first line, as herein provided for, upon the payment of all additional damages, and subject to the same conditions, provided assent and approval of the Secretary of the Interior, be had herefor, if within the jurisdication of such secretary at that time
