RENTAL CONTRACT

This Contract made and entered into this 22nd day of October A.D. 1910 by and between Chisso Childers Guardian for Lena Hopper (nee Childers) of Tulsa County Okla, for and on behalf of Lena Hopper (Nee Childers) who is Seventeen years old and a citizen of the Creek Nation, party of the first part, and G.F. Linihan party of the second part.

Witnesseth, that for and in consideration of the covenant and agreement hereinafter made by the party of the second part the party of the first part this day and by these presents do demise and let to the party of the second party heirs and assigns for agricultural purposes for the term of four years from the first day of January A.D. 1911 the following described parcels of land. $\frac{W}{2}$ of the $SE\frac{1}{4}$ of Section 5, Township 19 N. Range 14 E.; $NE\frac{1}{4}$ of the $SE\frac{1}{4}$ of Section 5, Township 19 N. Range 14 E.

It is understood and agreed that the party of the second part, shall pay to the party of the first part a rental of \$----per annum during the term of this contract payable, as follows: One Hundred dollars cash the receipt of which is hereby acknowledged said One hundred dollars is payment in full for the year 1911, Then Eighty dollars per annum during the term of this Contract, Payable on the first day of January of each year.
