North half of Southwest quarter of southwest quarter (N¹/₂ of SW¹/₄ of SW¹/₄ of section 36, township 21 north, range 12 east. *ling 40 hords*)

Also there is hereby granted a right to erect and maintain a telephone and telegraph line. The rights herein granted shall permit the use of such land as may be necessary for said pipe line for said telegraph and telephone line, and shall also permit the grantee herein, its successors and assigns, to do whatever may be necessary to their construction or for the enjoyment of the rights herein granted, including the right of ingress and egress to and from said tract of land for the purpose oflaying, maintaining, repairing and restoring of said pipe line and said telegraph line and telephone line, and for removing of same when desired by grantee its successors and assigns? It is understood that the person securing this right of way for said company is without authority to make any agreement, covenant or promises in its behalf not herein specifically shown, and this instrument is delivered and accepted upon the distinct understanding that the consideration herein above stated is the sole consideration and inducement therefor.
