Whereas, the Board of Directors of said Buckeye. Oil and gas Company did on the loth day of October 1910 a resolution authorizing the sale of said lease to O.M. Lancaster and P. M. Kerr, for the sum of Nine Thousand Dollars (\$9000.00)) said sale and assignment to include and convey to the said O.M. Lancaster and P.M.
