- 8. The second party, may at any time remove all his property and reconvey the part -- of the first part, or assigns the premises hereby granted, and thereupon this instrument shall become null and void.
- 9. The second party shall have the right to erect, maintain, operate and remove all necessary pipes, pipe lines, steam, water, gas and shackle li nes connecting with like lines to and from adjoining lands controlled by the second party.

It Is Understood between the parties to this agreement that all conditions between the part -- hereto shall extend to their heirs, executors administrators, successors and assigns.
