RELEASE OF OIL AND GAS LEASE.

WHEREAS on the 1st day of November, 1909 Addie Gravitt made, executed and delivered to The March Oil Company, a corporation of Tulsa, Oklahoma an oil and gas lease upon the premises hereinafter described, which said lease was recorded in Book 73 at Page 298 in the office of the Register of Deeds of Tulsa County, State of Oklahoma;

AND WHEREAS, on the 17th day of May, 1910, The March Oil Company made executed and delivered to Chas Page and R.A. Josey an assignment of the above mentioned lease, which said assignment was recorded in Book 98 at Page 383 in the office of the Register of Deeds of Tulsa County, State of Oklahoma,

AND WHEREAS, said lease contains the following provisions:

"The party of the second part, its successors and assigns shall have the right at any time on payment of one (\$1.00) dollar, to party of the first part, her heirs, executors, administrators, and assigns, to surrender this lease for cancellation after which all payments and liabilities thereafter to accrue under and by virtue of its terms shall cease and determine"

AND WHEREAS, Chas Page and R.A. Josey, assignees of the party of the second part now ^{desire} declare to avail themselves of the foregoing provision, and to surrender said lease for cancellation, and has this day and does with these presents tender and deliver to the party of the first part the sum of One (\$1.00) dollar, pursuant to the terms of said provision.

AND NOW, as aforesaid, the parties of the second part do hereby surrender, release and quit claim all of their right, title and interest in and to the following described property located in Tulsa County, State of Oklahoma, to-wit:

The North west Quarter of the South East Quarter of Sec. 30, Twp. 20 North, Range 14 East North Half of the North east quarter of the South East Quarter of Sec 30, Twp. 20 North, Range 14 East; South east quarter of the North West Quarter of the South West Quarter of Sec. 28, Twp. 20 North, Range 14 East, containing 70 acres, more or less unto the party of the first part, her heirs, administrators, successors and assigns.
