RELEASE OF OIL AND GAS LEASE.

WHEREAS, on the 1st day of November, 1909, Joe H. Berry and Minnie E. Berry, his wife, made, executed and delivered to the March Oil Company, a corporation of Tulsa, Oklahoma, an oil and gas lease upon the premises herein-after described which said lease was recorded in book 61 at Page 225 in the office of the register of Deeds of Tulsa County, State of Oklahoma;

AND WHEREAS, on the 17th day of May, 1910, The March Oil Company made, executed and delivered to Chas Page and R.A. Josey an assignment of the above mentioned lease, which said assignment was recorded in Book 98 at Page 383, in the office of the register of Deeds of Tulsa County, State of Oklahoma;

And whereas, said lease contains the following provision:

"The party of the second part, its successors and assigns, shall have the right at any time on payment of One (\$1.00) dollars, to parties of the first part their heirs, executors, administrators and assigns, to surrender this lease for cancellation after which all payment and liabilities thereafter to accrue under and by virtue of its terms shall cease and determine"

And whereas, Chas Page and R.A. Josey, assignees of the party of the second part now desires to avail themselves of the foregoing provision, and to surrender said lease for cancellation, and has this day and does with these presents, tender and deliver to the parties of the first part the sum of One (\$1.00) dollar, pursuant to the terms of said provision.

And, now, as aforesaid, the parties of the second part do hereby surrender, release and quit claim all of their right, title and interest in and to the following described property located in Tulsa County, State of Oklahoma, to-wit:

The north 19.23 acres of Lot 4, Sec 7, Twp. 20 North, Range 14, East being a part of the allotment of William S. Harlow; the West 17.82 acres of Lot 1 and the South-east 10 acres of Lot 1; The east half of the North east quarter of the North west quarter and the South west Quarter of the North east quarter of the North west quarter of Sec. 19, Twp. 20, North, Range 14 East, being a part of the allotment of John Harlow, containing in all 80 acres, more or less, unto the parties of the first part, their heirs, administrators successors and assigns.
