RELEASE OF OIL AND GAS LEASE.

WHEREAS, on the 1st day of November, 1909, Luther O. Gravitt made, executed and delivered to the March Oil Company, a corporation of Tulsa Oklahoma, an oil and gas lease upon the premises hereinafter described, which said lease was recorded in Book 73 at Page 326 in the office of the Register of Deeds of Tulsa County, State of Oklahoma;

And whereas, on the 17th day of May 1910, The March Oil Company made, executed and delivered to Chas Page and R.A. Josey an assignment of the above mentioned lease, which said assignment was recorded in book 98 at Page 833, in the office of the register of Deeds of Tulsa county, State of Oklahoma;

And whereas, said lease contains the following provision:

"The party of the second part, its successors and assigns, shall have the right at any time on payment of One (\$1.00) dollar to party of the first part, his heirs, executors, administrators and assigns, to surrender this lease for cancellation after which all payments and liabilities thereafter to accrue under and by virtue of its terms shall cease and determine"

And whereas, Chas. Page and R.A. Josey, assignees of the party of the second part now desires to avail themselves of the foregoing provision, and to surrender said lease for cancellation, and has this day and does with these presents, tender and deliver to the party of the first part the sum of One (\$1.00) dollar, pursuant to the terms of said provision.

And Now, as aforesaid, the parties of the second part do hereby surrender, release and quit claim all of their right, title and interest in and to the following described property located in Tulsa County, State of Oklahoma, to-wit:

The west Half of the North east quarter of South west quarter (less 1:06 acres St L. & S.F. R.R.) & North east quarter of North east quarter of South west quarter (less .21 acres St L & S.F. R.R.) of Sec 30, Twp. 20 North Range 14, East, containing 30 acres, more or less, unto the party of the first part, his heirs, administrators, successors and assigns.
