RIGHT OF WAY.

COMPARED

FOR AND IN CONSIDERATION OF Eighteen dollars (\$18.00) dollars to us in hand paid, receipt of which is hereby acknowledged, Chauncey A. Owen & Katherine W. Owen, his wife, do hereby grant to The Prairie Oil & Gas Company, its successors or assigns, the right of way to lay, maintain, operate and remove a pipe line for the transportation of oil or gas on, over, and through our lands situate in Tulsa County, State of Oklahoma, described as follows, to-wit:

SW 1/4 of NE 1/4 Section 3, Township 19 Range 12 with ingress and egress to and from the same. The said grantor, heirs or assigns to fully use and enjoy the said premises, except for the purposes hereinbefore granted to the said The Prairie Oil & Gas Company, which hereby agrees to pay any damages which may arise from the laying, maintaining and operating said pipe line; said damage if not mutually agreed upon to be ascertained and determined by three disinterested persons, one thereof to be appointed by the said grantor, heirs or assigns, one by The Prairie Oil & Gas Company, its successors or assigns and the third by the two so appointed as aforesaid and the award of such three persons shall be final and conclusive. also to have the right to change the size of its pipes, the damage, if any, in making such change to be paid by the said The Prairie Oil & Gas Company Pipe line to be buried.
