OIL AND GAS LEASE.

THIS LEASE, made this 31st day of October A.D. 1910, by an between Frank Trusler, guardian of Lucile Frances Trusler, a minor, of---of the first part and E.A. Ross, of Tu lsa, Oklahoma, of the second part.

Witnesseth, That the said party of the first part, in consideration of \$80.00 in hand paid, the receipt of which is hereby acknowledged, and the stupulations, rents, and covenants herein after contained, on the part of the said party of the second part, his heirs, executors, administrators successors and assigns, to be paid, kept and prformed, has granted, demised and let unto the said party of the second part, his heirs, executors, administrators, successors and assigns, for the sole and only purpose of drilling and operating for Petroleum Oil and Gas for the term of five years or as long thereafter as Oil Or Gas is found in paying quantities, all that certain tract of land, situated in the county of Tulsa, State of Oklahoma, and articularly described as follows, to-wit:

The Southwest Quarter of the Northwest Quarter and the Northwest Quarter of the Southwest Quarter of Section Twelve (12) in Township Seventeen (17) North, Range Thirteen (13) East of the Indian B ase and Meridian containing 80 acres, and Lot 3, of Section 11, Township 17 Range 13 East, Tulsa County, Oklahoma, containing 2:85 acres containing 82.85 acres more or less; excepting and reserving therefrom---feet abound the buildings on said premises upon which there shall be no wellsdrilled; the boundaries of which shall be designated and fixed by the said party of the first part.
