OIL AND GAS MINING LEASE BY GUARDIAN, UNDER ORDER OF COURT.

KNOW ALL MEN BY THESE PRESENTS:

That heretofore on the 13th day of September 1910, G.W. Barnes as Guardian of the Estate of Viola Edwards, a minor, filed in the County Court of Muskogee County, State of Oklahoma, his petition for leave to lease for oil and gas purposes, the land hereinafter described, belonging to his said ward, and

Whereas the said County Court did on the 13 day of September 1910, make an order of sale directing the said Guardian, G.W. Barnes, to sell at private sale to the highest and best bidder an oil and gas mining lease on the said land of his ward during the minority of his said ward, or until December 2, 1918, and

Whereas the said Guardian sold said oil and gas lease to G.W. Barnes Jr. on the 20th day of September 1910, as shown by his report of said sale to said Court, and

Whereas the said County Court did on the 28th day of October, 1910 make an order confirming and approving said sale and ordering and directing the said Guardian to execute a lease to the said purchaser, G.W. Barnes Jr., and copy of the order was duly recorded in the office of the Register of Deeds of Tulsa County on the ___ day of _____ 1910, at page ___ of Volume ___ of the records in said office,

Therefore, this Agreement made and entered into in triplicate on the 10th day of October 1910, by and between G.W. Barnes as Guardian of the Estate of Viola Edwards, a minor, of Muskogee, Oklahoma, party of the first part, lessor, and G.W. Barnes Jr. of Muskogee, Oklahoma, party of the second part, lessee,

WITNESSETH: That the said party of the first part, for and in consideration of the sum of Four Thousand two hundred (\$4200.00) dollars, to him in hand well and truly paid by the said party of the second part, receipt of which is hereby acknowledged, and of the covenants and agreements herein-after contained on the part of the party of the second part to be kept and performed, has granted, demised, leased and let, and by these presents does grant, demise, lease and let unto said second party, his heirs and assigns, for the sole and only purpose of mining and operating for oil and gas, and of laying pipe lines and of building tanks, powers, stations and structures thereon,
