ASSIGNMENT OF OIL AND GAS MINING LEASE.

KNOW ALL MEN BY THESE PRESENTS, That whereas heretofore, to-wit on the 28th day of October A.D. 1910, Lou McLane and Austin McLane, her husband, did make, execute, acknowledge and deliver a certain oil and gas mining lease on the East $\frac{1}{4}$ of the Northeast $\frac{1}{4}$ of Section 17, Township Twenty one (21) North, Range 13 East, Tulsa County, Oklahoma, to B. Rabinovitz, his heirs and assigns, and

Whereas said lease was duly filed for record with the Register of Deeds of Tulsa County, Oklahoma, on the 31st day of October, 1910, and recorded in Record 92, Page 194 of the records of said Register of Deeds office;

Now therefore, B. Rabinovitz, in consideration of One Dollar (\$1.00) and other good and valuable considerations in hand paid by Morris Shear, the receipt of which is hereby acknowledged, does hereby sell, assign, transfer, set over, set off and convey unto said Morris Shear, his heirs and assigns, an undivided one half ($\frac{1}{2}$) interest in and to the above mentioned oil and gas mining lease executed on the 28th day of October A.D. 1910 by Lou McLane and Austin McLane, her husband, to the said B. Rabinovitz on the following described tract of land, to-wit: The East Half ($\frac{1}{2}$) of the Northeast Quarter ($\frac{1}{4}$) of Section Seventeen (17) Township Twenty one (21) North, Range Thirteen (13) East, Tulsa County, Oklahoma, containing in all 80 acres and being the allotment of the said Lou McLane said lease being filed for record in the office of the Register of Deeds of Tulsa County, Oklahoma, on the 31st day of October, 1910, and recorded in Record 92, Page 194

This assignment is intended to convey and does convey to said Morris Shear, his heirs and assigns, an undivided one half ($\frac{1}{2}$) interest in and to said lease as above mentioned and set out and is given subject to the terms and conditions as mentioned and set out in said lease.

This assignment is and shall be binding upon the parties hereto, their heirs, administrators, and assigns.
