In consideration of Four and No/100 dollars this day paid to Green Terrell by The Gulf Pipe Line Company of Oklahoma, the receipt whereof is hereby acknowledged I do hereby grant and convey unto said Gulf Pipe Line Comany of Oklahoma, its successors and assigns, the right to locate, mainfain and operate a pipe line form the purpose of conveyance of oil over, through and upon that certain tract of land situated in Tulsa County, and thus described. Also there is hereby granted a rgight to erect and maintain a telephone and telegraph line.
