In consideration of Fifteen and no/100 dollars this daypaid to W.T. McGinniss by The Gulf Pipe Line company of Oklahoma, the receipt whereof is hereby acknowledged I do hereby grant and convey unto said Gulf Pipe Line Company of Oklahoma, its successors and assigns, the right to locate, maintain and operate a pipe line for the purpose of conveyance of oil over, through and upon that certain tract of land situated in Tulsa County, and thus described. his undivided 2/3 interest in the 1 of SW of section 12 twp. 21 north range 12, east, the above amount being in payment of right of way privileges and damage to crops, fences and trees.

Also there is hereby granted a right to erect and maintain a telephone and telegraph line. The rights herein granted shall permit the use of such and as may be necessary for said pipe line for said telegraph and telephone line, and shall also permit the grantee herein, its successors and assigns, to do whatever may be necessary to their construction or for the enjoyment of the rights nerein granted, including the right of ingress and egress to and from said tract f land for the purpose of laying, maintaining repairing and restoring of said pipe line and telegraph and telephone line, and for removing of same when desired by the grantee, its successors and assigns. To have and to hold the said easement unto the said culf Pipe Line company of Oklahoma, its successors and assigns, so long as the same shall be useul for the purpose desired of by said grantee, which by the acceptance hereof covehants and agrees with the grantor that the pipe line shall be buried so as not to interfere with the cultivation of the same.

It is understood that the person securing this right of way for said company is without authority to make any agreement, covenant or promise in its ehalf not herein specifically shown, and this instrument is delivered and accepted pon the distinct understanding that the consideration herein above stated is the ole consideration and inducement therefor.
