In consideration of Eight No/100 dollars this day paid to Lucile Buffington, T.M. Buffington, Gdn. by The Gulf pipe Line Company of Oklahoma, the receipt whereof is hereby acknowledged. do hereby grant and convey unto said Gulf Pipe Line Company of Oklahoma, its successors and assigns, the right to locate, maintain and operate a pipe line for the purpee of conveyance of oil over, through and upon that certain tract of land situated in Tulsa County, Oklahoma, and thus described, The SWH of the NWH of section 24, township 21 North, range 12 east, 80 rods.

Also there is hereby granted a right to erect and maintain a telein Atoliga A. The rights herein grankd shall permit the use of such land as phone may be necessary for said pipe line for said telegraph and telephone line, and shall also permit the grantee, herein, its successors and assigns, to do whatever may be necessary to their construction or for the enjoyment of the rights herein granted including the right of ingress and egress to and from said tract of land for the purpose of laying, maintaining, repairing and restoring of said pipe line and said telegraph and telephone line, and for removing of same when desired by the grantee, its successors and assigns.
