COMPARED (\$10.00) In consideration of Ten 00/100 dollars this day paid to Laura B. Walden O.E. Spurgeon, Guardian, by The Gulf Pipe Line Company of Oklahoma, the receipt whereof is hereby acknowledged I do hereby) grant and convey unto said Gulf Pipe Line Company of Oklahoma, its successors and assigns, the right to locate, maintain and operate a pipe line for the purpose of conveyance of oil over, through and upon that certain tract of land situated in Tulsa County, Oklahoma and thus described: No of SEt of NEt Sec 26, T 22 N.R. 12 E. 40 rods.

Also there is hereby granted a right to erect and maintain a telephone and telegraph line. The rights herein granted shall permit the use of such land as may be necessary for said pipe line for said telegraph and telephone line, and shall also permit the grantee herein, its successors and assigns, to do whatever may be necessary to their construction or for the enjoyment of The rights herein granted, including the right of ingress and egress to and from said tract of land for the purpose of laying, maintaining, repairing and restoring of said pipe line and said telegraph and telephone line, and for removing of same when desired by the grante, its successors and assigns And the right to lay, construct, operate, maintain and remove additional pipe lines, telegrpah and telephone systems, over said lands, parallel with the above lines, is hereby granted to the Gulf Pipe Line Company of Oklahoma, its successors and assigns, upon payment of an additional sum equal to the consideration above named.
