

-ASSIGNMENT.

COMPALED

This agreement made and entered into this 7th day of January, 1911, by and between Mrs. Virginia Duncan, formerly Virginia Light, of Tulsa, Tulsa County, Oklahoma, party of the first part, and F. R. Letcher, Trustee, of Tulsa, Tulsa County, Oklahoma, party of the second part, witnesseth:

That for and in consideration of the sum of Seven Hundred twenty-six and 48/100 (\$726.48) Dollars, cash in hand paid, receipt being hereby acknowledged, the said party of the first part assigns, transfers and conveys unto the said party of the second part, his heirs and assigns, all of her right, title and interest, in and to the following described oil leases, to-wit:

One oil and gas lease, bearing date of May 31, 1910, by and between William Anderson, guardian of Amy Tife, party of the second part, and Virginia Light, party of the second part, said leases being upon the following described tract of land:

The southwest quarter of the Southwest quarter of section fifteen (15), township nineteen (19), range eleven (11), ^{and the north one half of} and the northwest quarter of the northwest quarter of section twenty-two (22), township nineteen (19), range eleven (11), and the southeast quarter of the southwest quarter of section fifteen (15) township nineteen (19), range eleven (11), and lot six (6) and lot seven (7) of section fifteen, (15), township nineteen (19) range eleven (11), being in all, one hundred sixty-one and 44/100 (161.44) acres, according to the United States government survey thereof, and being in the county of Tulsa, State of Oklahoma.

Which said lease was filed of record in the register of deeds office, at Tulsa, Tulsa County, Oklahoma, on the 16th day of June, 1910, at 3:30 o'clock P. M., and recorded in record 86, page 508.

One lease, bearing date of May 31, 1910, by and between Amy Tife, (single) of Tulsa County, Oklahoma, party of the first part, and Virginia Light of Tulsa County, Oklahoma party of the second part, covering the land above described, said lease filed for record at Tulsa, Tulsa County, Oklahoma, with the register of deeds, of said county, June 16, 1910, at 3:30 P. M., and recorded in record 86, page 510.

One lease, bearing date of June 7, 1910, by and between William Anderson, administrator of the estate of Soda Tife, deceased, of Tulsa County, Oklahoma, party of the first part, and Virginia Light, of Tulsa County, Oklahoma, party of the second part, said lease covering all the land above described, and filed for record in said county, with the register of deeds, of Tulsa County, state of Oklahoma, on the 16th day of June, 1910, at 3:30 P. M., and recorded in record 86, page 513.
