In event restriction on elemation shall be removed from all the lesschold Premises described above, this lease shall be released from the supervision of the secretary of the interior, such release to take effect without further agreement, from the date such restrictions are removed, and thereupon the authority and Power delegated to the secretary of the interior as herein Provided shall cease, and all Payments required to be made to the United States Indian Superintendent shall thereafter be made to lessor or the then owner of said land; and changes and regulations thereafter made by the secretary of the interior applicable to oil and mas leases shall not apply to this lease.
