OIL AND GAS LEASE.

AGREEMENT, Made and entered into this 23rd day of Dec A. D. 1910 by and between Chas. E. Hutcherson and Stella J. Hutcherson , his wife of Tulsa Count y and State of Oklahoma lessor, and C. T. H. oleman of Branson, Kans, lesse.

Witnesseth, That the lessor in consideration of One dollar the receipt of which is hereby acknowledged and the covenants and agreements hereina\_fter contained and to be kept performed by the lessee, do as hereby grant unto the lessee his heirs, successors and assigns all the Oil and Gas in and under the following described tract of land for the sole purpose and with the exclusive right of operating thereon for oil and gas to ogether with the right of way over and across said premises to all places of operation,

by said lessee lying adjacent thereto, the right to erect derricks and all other necessary buildings, lay pipes and powers over and across said premises, and to use water gas and oil to drill and operate wells on this and adjacent leases, also the right to remove at any time any property placed thereon by Lessee, which tract of land is situated in the County of Tulsa, and State of Oklahoma and described as follows, to-wit:

To have and to hold the same unto the Lessee his heirs, successors and assigns, for the term of ten years from the date hereof, and as much longer thereafter as oil and gas is fond in paying quantities thereon; yielding and paying to the lessor the one eighth (1/8) part of all the oil produced and saved from the premises, delivered free of expense into tanks or pipe lines to the Lessor credit and should any well produce gas in sufficient quantities to justify marketing, the lessor shall be paid at the rate of One Hundred Fifty Dollars (\$150.00) per year for such welliso long as gas therfrom is sold and lessor is to have gas for domestic use in one dwelling house on the premises free of cost during the same time he making his own connections.

It is agreed that in case no well is completed on above described premises within twelve months from the date hereof this lease shell become absolut ely null and void unless lessee shall pay for further delay a rental of Highty Dollars (\$80.00) per year, payable annually in advance, until a well is completed on these premises and it is expressly agreed application that if such payments be of throughly made ontil a well is completed on said premises, this lease shall continue until the expiration of the
