

## ASSIGNMENT OF INTEREST.

Know all men by these Presents: that for and in consideration of the sum of Nine Hundred Forty-four and 67/100 (\$944.67) Dollars, cash in hand to me paid by C. L. Wallis, on this day, I, the undersigned, R. W. Kellough, do hereby and by these Presents, convey, sell, transfer and assign unto the said C. L. Wallis, his heirs and assigns, all my right title and interest in and to a certain contract executed by and between The Booth Oil and Gas Company, and George T. Guarnsey, John Smith, W. L. Truby, J.
