COMPARED

OIL AND GAS LEASE.

In consideration of the sum of One Hundred twenty dollar, the receipt of which is acknowledged by the first Party Hollis Collins, guardian of the Person and estate of James Davis, a minor, first Party hereby grants and conveys unto W. C. Guiler, C. E. DeLoe and Homer S. Crosman second Party, all the oil and gas in and under the Premises hereinafter described, together with said Premises for the Purpose and with the exclusive right to enter therein at all these by himself, agents, assigns or employes, to drill and operate wells, for oil, gas and water, and to erect, maintain and occupy, repair and remove all buildings, telephone Poles and wires, structures, Pipe lines, machinery and appliances that seems Party may deem necessary, convenient or expedient to the Production of oil, gas and water thereon, and the transportation of oil and gas on, upon and over said premises and the highways along the same, except that firstparty shall have the full one-eighth part of all oil Produced and saved on the Premises, delivered free of cost in the pipe line to which second Party may connect his well, and first Party agrees to accept said share of said oil as full compensation for all the Poducts of each well in which oil is found.
