The northeast quarter (1) of section number one (1) in township number seventeen (17) north of range number twelve (12) east of the Indian base and meridian. which said deed of conveyance has been duly filed for record in the office of the register of deeds of Tulsa county, Oklahoma, and recorde d in the records of said office in book 67 and at Page 559 thereof.

That the said Isaac Tiger died some time in the year 190% andthat he left surviving him no wife ad no children, but that he left at his death, as his sole and only heirs at law, on brother, Jacob Tiger, and one sister, Minnie Steel, nee Tiger, who died some time during the year 1903, near Sonora, in what is now Okmulgee county, Oklahoma, leaving surviving her no husband, but leaving at her death as her sole and only heir at law, on child.
