The Party of the first Part reserves the right to cancel this lease either Jan 1st 1912 or Jan 1st 1913, if he should sell the land.

Party of second Part to pile loose rock in S W corner & keep fence on south & west in repair.

To have and to hold the same, unto the said Party of the first Part, from the 28th day of Jan 1911, to the first day of Jan 1914.

And said Parties of the second Part in consideration of the leasing the Premises, as above set forth covenants and agree with the said Party of the first Part, to pay the said Party of the first Part, heirs or assigns, as rent for the same the total amount or sum of one hundred sixty five dollars, in 3 Payments, as follows, to-wit:

55.00 " 1st 1913.

The covenants herein shall extend to and be binding upon the heirs, executors and administrators of the Parties to this lease.
