LEASE CONTRACT THREE YEARS

This memorandum made and entered into this the Fourth day of January A. D. 1911 by and between Belle Williams of catdosa, Okla party of the first part and T. J. Daugherty of catdosa, Okla party of the second part, witnesseth; That for and in consideration of the covenants and agreements hereinafter made by the party of the second part, the party of the first part has this day and by these presents does demise, and let to the party of the second part his heirs and assigns for agricultural purposes for the term of three years from date the following described parcels of land. The northwest $\frac{1}{4}$ (NW) of the southeast $\frac{1}{4}$ (SE) and the east $\frac{1}{2}$ of the N.W. $\frac{1}{4}$ of the northwest $\frac{1}{4}$ (NW) in Sec. 21 T.20 R. 14 in Tulsa County, Okla, and allotted to Belle Williams as her allotment as a citizen of the Cherokee Nation, It is understood and agreed that the part of the second part will pay the party of the first part as rental the sum of fifty Dollars (\$50.00) per annum during the term of this contract payable as follows: Fifteen dollar (\$15.00) the receipt of which is hereby acknowledged and (\$35.00) January 1st, 1911 and (\$50.00) January 1912 and \$50.00 January 1st, 1913, said second party to put fence on line and break out not less than 30 acres of land all to be done by this time this contract expires.
