ORDER COTFIRMING DEED.

\*\*\*\*\*\*\*\*\*

In the county court of the state of Oklahoma in and for Tulsa county. In the matter of the estate of Wilson Rolland, deceased. Probate No 927. Order confirming deed by full-blood Indian heirs.

And now, to-wit; on this 4th day of February, A. D. 1911, there coming on before this court for hearing in the above entitled cause the joint petition of Temarye Rolland Susie Parkinson nee Rolland and Jim Parkinson asking this court to approve a certain doed executed by them on February 4th 1911, to Laude Rolland for a consideration of one dollar and other good and valuable considerations and conveying and quit-claiming unto the said Maude Rolland an undivided one-half interest in and to the fee simple title to the southeast quarter (SE;) of section thirteen (13) of township sixteen (16) north and of range twelve (12) east of the Indian base and meridian and lying in Tulsa county, Oklahoma the said land being the allotment of one Wilson Rolland, deceased, who was creek indian No 1900, according to the enrollment of Creek Indian citizens as made by the commission to the five civilized tribes, and the said petitioners all appearing in person and by F. E. Sutton their attorney and asks that the above mentioned deed be approved and confirmed in all particulars, and the court hearing evidence and being fully advised in the premises, finds;

That the said decedent "ilson Rolland was creek Indian No 1900 according to the enrollment of Creek Indians prepared by the com ission to the five civilized tribes; that as such creek Indian citizen he received as and for his allotment the southeest quarter (SE) of section thirteen (13) of township sixteen (16) north and of range twelve (12) east of the Indian base and meridian and situated in Tulsa county, Oklahoma; that said decedent was still the owner of the fee simple title to said land at the time of his demise; that said decedent died intestate on or about March 28th 1910, and was at that date maintaining his permanent residence inTulsa county, Oklahoma; that he left as his only possible heirs his widow Maude Rolland, his brother Temarye Rolland who is creek Indian No 1901, and his sister Susie Parkinson nee Rolland who is creek Indian No 1899. That said widow Maude Rolland is a non-citizen of the creek nation of Indians and that the petitioners herein Temarye Rolland and Susie Parkinson nee Rolland are both enrolled as full blood creek Indians. The court further finds that there is a doubt among the minds of the bar of the state of Oklahoma as to how it will be held by the higher courts as to just what portions the widow of said decedent, Wilson Rolland, and the petitioners herein will take as hoirs-at-law of said decede t and that the misunderstanding or doubt in this regardás to the above described land is now pending in the district court of Tulsa county, Oklahoma, incivil case No 2131 entitled Temerye Rolland et al vs Susie Parkinson et al, for a partiblon of said land and quieting the title as against the said Maude Rolland as
