All demages thereafter to fences, crops and premises, which may be suffered by reason of the maintenance, operation or alteration of said lines of pipe to be assessed under the direction of the Secretary of the Interior, or, in case of remo val of restrictions asto the then owner thereof, said damages, if not mutually agreed up on to be ascertained and determined by three disinterested persons one thereof to be appointed by the owner of the premises, one by The Texas Company, its successors or assigns and the third by the two so appointed as aforesaid and the award of such three persons shall be final and conclusive.
