OIL AND GAS MINING LEASE BY GUARDIAN UNDER ORDER OF COURT.

COMPARED

Know all men by these presents, that h~~et~~etofore, on the 5th day of January, 1911, A. E. Palmer, as guardian of the estate of Edgar Palmer, a minor, filed in the county court of Tulsa County, state of Oklahoma, his petition for leave to lease for oil and gas purposes, the land hereinafter described belonging to his said ward, and

Whereas, the said County court, did, on the 5th day of January, 1911, make an order of sale, directing the said guardian A. E. Palmer to sell at private sale, to the highest and best bidder, an oil and gas lease on the said land of his said ward, during the minority of his said ward, and as much longer thereafter as oil or gas is found in paying quantities and

Whereas, the said guardian sold said oil and gas lease to A. W. Shulthis, on the 5th day of January, 1911, as shown by his report of said sale to said court, and

Whereas, the said County court, did, on the 5th day of January, 1911, make an order confirming said sale, and ordering and directing the said guardian to execute a lease to the said purchaser, A. W. Shulthis, a copy of which order was duly recorded in the office of the Register of Deeds of Tulsa County, State of Oklahoma, on the 6th day of Jan 1911, at page 61 of Vol. 99, of Miscel records, in said office;

Therefore, this agreement, made and entered into in duplicate, the 5th day of January, A. D. 1911, by and between A. E. Palmer, as guardian of the estate of Edgar Palmer, a minor of Tulsa County, Oklahoma, party of the first part, lessor, and A. W. Shulthis, party of the second part, lessee.

Witnesseth, that the said party of the first part for and in consideration of the sum of Five Hundred (\$500.00) Dollars, to him in hand well and truly paid by the said party of the second part the receipt of which is hereby acknowledged, and of the covenants and agreements hereinafter contained on the part of the party of the second part to be paid, kept, and performed, has granted, demised, leased and let and by these presents does grant, demise, lease and let unto the said second party, heirs, successors or assigns, for the sole and only purpose of mining and operating for oil and gas, and of laying pipe
