(f) To act as executor under last will and testament; as the administrator of the estate of any deceased person; as guardian or curator of any infant, insane person, idiot, habitual drunkard, or person who has been adjudged incompetent; or trustee under will, or by appointment of court, and to take entire charge of estates, real and personal; act as trustee for any convict in the penitentiary under the appointment of any court of record having jurisdiction; act as agent of any Indian Nation, tribe or individual relative to any rights, claims or demands against the Government, or any person or corporation; and act as the agent of the government of the United States in all matters in the disbursement of funds and payments to any individual Indian, nation or tribe.

(g) To act as trustee under mortgages, deeds of trust to secure real estate loans, loans on personal property, and corporation bonds.

(h) To act as custodian of wills and other important papers contracts and property placed in escrow.

(i) To buy, own and sell real estate, to purchase, own and hold the stock of other corporations and its own stock; to buy, own and sell real and personal securities, and loan money on real and personal securities; to invest funds in and sell bonds, mortgages, real estate, and stocks of corporations; and transact a general investment business, on its own account, and on behalf of others; to purchase and sell or take charge of and receive the rents, issues and profits of any real estate, for any person, firm or corporation.

(j) To act as agent for responsible fire insurance companies in placing policies on property, and act as agent for Old Line insurance companies in the sale of life insurance and payment of claims.

(k) To receive money in trust and to accumulate the same at such rate of interest as may be obtained or agreed upon, or to allow such interest thereof as may be agreed upon, not exceeding in either case, the legal rate, and do a general savings bank business.

(l) To own, control and have a safety vault, or safety vaults/ and rent the boxes therein, upon such terms and for such corporation as may be agreed upon.

(m) To act as agent or attorney in fact for any person or corporation in the management and control of real or personal property and the sale or conveyance of the same, and for the investment of money, and to act for and represent corporations or persons under power and letters of attorney, and as agent for persons and corporations for the purpose of issuing, registering, transferring, or countersigning the certificates of stock, bonds, or other evidences of debt of any corporation, association, municipality, state or public authority, on such terms as may be agreed upon by the subscribers hereto.

FOURTH: To accept from and execute trusts for married women, and others, representing their personal property, whether real or personal, and act as agent for them in the management of such property, and generally to have and exercise such powers as are usually had and exercised by trust companies.

(o) To act as agent and attorney for individuals, firms or corporations in the collection of accounts, notes, and all evidences of indebtedness, claims and demands; prosecute and defend suits for others in any court, and compromise and settle all such matters.

SECOND: The capital stock, being One Hundred Thousand dollars (\$100,000), is divided into four thousand (4,000) shares of Twenty-five dollars (\$25.00) each.

THIRD: All of said capital stock, being One Hundred Thousand Dollars (\$100,000) has been subscribed and actually paid in by the subscribers.
