FIFTH: The amount of capital stock of said Corporation shall be for Thousand of which fleur Thousand Dollars has been subscribed by the Corpora ....Dollars has been subscribed by the Corporators aforesaid, and the residue thereof may be issued and disposed of as the Board of Directors may from time to time order and direct. SIXTH: The capital stock shall be divided into Four Hundred shares of the value of \$25.00 each.
