

FIFTH: The amount of capital stock of said Corporation shall be One Hundred Thousand, Dollars; of which Ten Thousand Dollars has been subscribed by the Corporators aforesaid, and the residue thereof may be issued and disposed of as the Board of Directors may from time to time order and direct.

SIXTH: The capital stock shall be divided into One Thousand shares of the value of \$25.00 each.
